We have reviewed your client's progress under the Ticket to Work Program and found that he has not met the requirements for the first 12-month timely progress review. This is because:

As a reminder, Social Security does not conduct the Medical Continuing Disability Review if your client is using his ticket. However, if we find that your client is not using his ticket, Social Security may conduct a medical review of your client's case. If your client still meets the disability rules, your client's benefits may continue.

Your Client's Next Review

The next time we review your case we will need the following:

- Proof of work and earnings at or above the substantial gainful activity level for at least 3 months out of any 12 month period beginning; [September 19, 2005](#); and
- The expectation from your organization that your client will work and earn at or above the substantial gainful activity level for at least 6 months out of any 12 month period beginning [September 19, 2006](#).
